#### **I. Predmet pogodbe**

##### **I. Subject of the contract**

Pogodba ureja medsebojna razmerja, pravice in obveznosti pogodbenih strank pri izvajanju praktičnega usposabljanja v študijskem letu \_\_\_\_\_, v okviru študijskega programa Turizem, ki ga izvaja FT UM, in sicer (obkrožite):

## II. Vsebina in potek praktičnega usposabljanja

### II. *Content and course of practical training*

Praktično usposabljanje poteka pod vodstvom mentorja, ki ga določi organizacija (v nadaljevanju mentor) in koordinatorja praktičnega pouka, katerega določi FT UM (v nadaljevanju koordinator). Mentor, določen s strani organizacije, mora imeti vsaj visokošolsko strokovno izobrazbo ali pet let primerljivih delovnih izkušenj.

Praktično usposabljanje poteka skladno s programom, ki ga pred podpisom te pogodbe potrdira mentor in koordinator in je priloga te pogodbe (v nadaljevanju Program).

*Practical training is carried out under the guidance of a mentor, who is appointed by the organization (hereinafter: mentor) and the coordinator of the practical training, who is appointed by FT UM (hereinafter: coordinator). Practical training takes place in accordance with the program which must be approved by the mentor and coordinator before signing the contract and is an annex to this contract (hereinafter: program).*

## III. Obveznosti študenta/ke

### III. *Obligations of the student*

Študent/ka se zavezuje, da bo:

- upošteval/a predpise o varnosti in zdravju pri delu, pazljivo opravljal/a delo in uporabljal/a predpisana zaščitna sredstva, da zavaruje svoje življenje in zdravje ter življenje in zdravje drugih oseb,
- v skladu z veljavno zakonodajo opravi/a ustrezen zdravstveni pregled,
- redno in v skladu s Programom opravlja/a praktično usposabljanje in upošteval/a navodila mentorja in koordinatorja,
- varoval/a poslovno skrivnost organizacije,
- izdelal/a zaključno pisno Poročilo o opravljenem praktičnem usposabljanju in ga po končanem praktičnem usposabljanju zagovarjal/a pred koordinatorjem praktičnega usposabljanja na FT UM,
- povrnil organizaciji morebitno z njegove strani naklepno ali iz malomarnosti povzročeno škodo.

*The student commits himself/herself to:*

- *comply with the regulations regarding the safety and health at work, carefully perform the tasks and use the prescribed protection measures to protect his/her life and health as well as the life and health of the others,*
- *carry out an appropriate medical examination in accordance with the applicable legislation,*
- *regularly perform practical training and take into account instructions from the mentor and coordinator in accordance with the program,*
- *guard the business secret of the organization,*
- *write a final written report on completed practical training and, after completing the practical training, to advocate the thesis before the Practical Training Coordinator at FT UM,*
- *refund the damage, which was caused deliberately or negligently, to the organization.*

## IV. Obveznosti FT UM

### IV. *FT UM obligations*

FT UM se zavezuje, da bo:

- imenovala koordinatorja praktičnega usposabljanja na FT UM, ki bo spremljal študenta/ko,
- vodila ustrezno dokumentacijo o poteku izvajanja praktičnega usposabljanja študenta/ke ter študentu/ki nudila strokovno pomoč pri izvajanju praktičnega usposabljanja
- spremljala usposabljanje študenta preko koordinatorja praktičnega usposabljanja,
- študenta/ko zavarovala oz. zanj plačala prispevek za posebne primere zavarovanja, v skladu s tretjim odstavkom 20. člena Zakona o pokojninskem in invalidskem zavarovanju (Uradni list RS, št. 96/2012, ZPIZ-2).

*FT UM commits itself to:*

- *appoint a practical training coordinator at FT UM, who will monitor the student's work,*
- *keep appropriate documentation regarding the course of the practical training of the student and to provide professional assistance in carrying out practical training,*
- *monitor the training of the student with the help of a practical training coordinator,*
- *insure the student or to pay a contribution for special cases of insurance in accordance with the third paragraph of Article 20 of the Pension and Disability Insurance Act (Official Gazette of the Republic of Slovenia, No. 96/2012, ZPIZ-2).*

**V. Obveznosti organizacije**

**V. Obligations of the organization**

Organizacija se zavezuje, da:

- *bo praktično usposabljanje študenta/ke izvedla skladno s programom, ki je priloga te pogodbe,*
- *da bo mentorju, določenem v točki II, omogočila opravljanje svetovanja in nadzora nad izvajanjem praktičnega usposabljanja,*
- *bo omogočila svetovanje in nadzor praktičnega usposabljanja koordinatorju iz FT UM;*
- *pred začetkom opravljanja praktičnega usposabljanja seznanila študenta/ko z delom in nalogami, ki jih bo opravljal/a,*
- *študenta/ko seznanila s predpisi o varnosti in zdravju pri delu ter s splošnimi in posebnimi nevarnostmi ter ukrepi za varno delo pri opravljanju praktičnega usposabljanja in mu/ji nudila potrebna zaščitna sredstva,*
- *v skladu z veljavno zakonodajo študenta/ko napotila na ustrezen zdravstveni pregled in krila stroške zdravstvenega pregleda,*
- *študentu/ki svetovala, ga usmerjala pri izdelavi Poročila o praktičnem usposabljanju ter ga po koncu usposabljanja potrdila,*
- *ob zaključku praktičnega usposabljanja izdala študentu/ki Potrdilo o izvedbi praktičnega usposabljanja,*
- *varovala osebne podatke študenta/ke v skladu z veljavno zakonodajo,*
- *v skladu s 17. in 49. členom Zakona o zdravstvenem varstvu in zdravstvenem zavarovanju (Uradni list RS, št: 9/92, s spremembami, ZZZV) zavarovala študenta/ko za primer poškodbe pri delu in poklicne bolezni za vsak mesec, v katerem študent/ka opravlja delo.*

*The organization commits itself to:*

- *carry out the practical training of the student in accordance with the program attached to this contract,*
- *enable the mentor, who was specified in point II, to provide advice and supervision over the implementation of practical training,*
- *provide advice and supervision of practical training to the FT UM coordinator,*
- *inform the student about the work and tasks that he / she will perform before the commencement of the practical training,*
- *inform the student with the regulations regarding occupational safety and health, general and special dangers and measures for safe work in the provision of practical training and to offer him / her the necessary protective measures,*
- *send the student to an appropriate medical examination and cover the costs of the medical examination in accordance with applicable legislation,*
- *advise the student, guide him/her in the preparation of the Practical Training Report and to confirm it after the end of the training,*
- *issue the student a Certificate of Practical Training at the end of the practical training,*
- *protect personal data of the student in accordance with the applicable legislation,*
- *insure the student in case of injuries at work and occupational diseases for each month of work in accordance with Articles 17 and 49 of the Health Care and Health Insurance Act (Official Gazette of the Republic of Slovenia, No. 9/92, as amended by the ZZZV).*

**VI. Veljavnost pogodbe**  
**VI. Validity of the contract**
